

6) Florida Department of Environmental Protection (FDEP) Resilience Project Grant

Jennifer shared with the Board that the CFRPC has received a grant from the Florida Department of Environmental Protection (FDEP) to create a plan or guidance manual that will help various entities coordinate regionally when conducting vulnerability assessments, developing adaptation plans, and prioritizing projects for implementation. This grant allows us to look at the Heartland Regional Resiliency project and bring together best management practices.

7) Polk County Adaptation Plan

CFRPC staff issued a Request for Qualifications to complete a Polk County Adaptation Plan consistent with the Florida Adaptation Planning Guidebook and Resilient Florida Legislation. The selected consultant will assess flood risks through advanced mapping and vulnerability analyses. Community engagement will be a critical component of this project to ensure the adaptation plan aligns with local needs and priorities. The Selection Committee has evaluated and ranked the two proposals received and requested that the Board approve the Selection Committee rankings and authorize the Executive Director to negotiate and execute a contract with the top ranked Firm and to authorize the Executive Director to negotiate and execute a contract with the second ranked firm should negotiations be unsuccessful with the top ranked firm.

8) Economic Recovery & Resiliency Federal Interagency Resource Exchange (FIRE) Listening Session

The Federal Economic Recovery Support Function, in collaboration with Florida's Regional Planning Councils and the Florida Department of Commerce, hosted a regional convening known as FIRE Listening Session on January 30, 2025. This session brought together local, state, and regional stakeholders with federal agencies to facilitate strategic discussions. The goal was to gather and validate information on the impacts of Hurricanes Helene and Milton and to connect identified needs with available resources.

9) Coastal and Heartland National Estuary Partnership

Jennifer Hecker, Executive Director of the Coastal and Heartland National Estuary Partnership (CHNEP), provided an update on regional activities. The partnership's coverage area overlaps with the CFRPC area including DeSoto, Hardee, Highlands, and Polk counties. Jennifer gave an overview of CHNEP which was formed in 1995 and is one of 28 congressionally designated "estuaries of national significance".

The Executive Director and Policy Board Members briefed the Council on the FRCA Policy Board meeting which was held in January in Tallahassee.

Background:

Regional Planning Councils are authorized and established in the Florida Statutes in Chapters 163 and 186, with powers and duties described in those chapters and numerous other places in the Statutes. Shortly before the beginning of this year's session of the Florida Legislature, bills were filed in the House (HB 1125) and Senate (SB 1264) which would eliminate Regional Planning Councils entirely from the Florida Statutes.

Analysis:

The proposed legislation would eliminate the statutory language authorizing and establishing Regional Planning Councils, as well as all the other references and duties, from the Statutes. The language is part of bills that cover a half-dozen disparate, unrelated topics. Thus, rather than call for denial of the bills, the proposed resolution asks that the language concerning Regional Planning Councils be removed from the bills.

Attached is a Fact Sheet which describes what Councils do across the state and the value provided to state and local governments, communities, and businesses – at no cost to the state and with no state employees. The work Regional Planning Councils do in the areas of Economic Development, Intergovernmental Relations, Urban Planning, Policy Development, Natural Resource Protection, and Emergency Management is impactful across the state and it is our intention, coordinated through the Florida Regional Councils Association, to share this work with the Legislature.

Recommendation:

Approve Resolution 2025-4A opposing elimination of Regional Planning Councils as proposed in House Bill 1125 and Senate Bill 1264 and any similar legislation.



RESOLUTION 2025-4A

A RESOLUTION OF THE CENTRAL FLORIDA REGIONAL PLANNING COUNCIL REPRESENTING THE LOCAL GOVERNMENTS OF DESOTO, HARDEE, HIGHLANDS, OKEECHOBEE AND POLK COUNTIES, FLORIDA; OPPOSING ELIMINATION OF STATUTORY AUTHORIZATION FOR REGIONAL PLANNING COUNCILS IN FLORIDA AS PROPOSED IN SENATE BILL 1264 AND HOUSE BILL 1125 OR SIMILAR PROPOSED LEGISLATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Central Florida Regional Planning Council's five county geographical area is comprised of DeSoto, Hardee, Highlands, Okeechobee, and Polk counties and 25 municipalities contained therein; and

WHEREAS, the Council is a multi-purpose regional governmental entity with policy responsibilities in the areas of affordable housing, economic development, emergency preparedness, energy, natural resources, urban planning, agriculture, and regional transportation; and

WHEREAS, for more than five decades Regional Planning Councils have served the public as Florida's only multipurpose regional entities that coordinate intergovernmental solutions to multijurisdictional issues identified by their member local governments; and

WHEREAS, the 67 counties in the state are divided into 10 Regional Planning Councils which perform functions in Economic Development, Transportation, Emergency Preparedness, Regional Convening, and Resilience to the extent and as directed by their member counties, cities, and gubernatorial appointees; and

WHEREAS, the Regional Planning Councils receive no regular general appropriation for operation from the State and, instead, are supported by Federal grant funds, local dues, local contracts, and State contracts for specific programs implemented on behalf of the State; and

WHEREAS, Regional Planning Councils serve a critical role in hazardous material response coordination and training through the Local Emergency Planning Committees (LEPCs) operated by each Council; and

WHEREAS, Regional Planning Councils regularly assist agencies in implementing their statutory duties and legislative directives, along with coordinating these duties and directives with local input; and

WHEREAS, Regional Planning Councils partner with local governments and various agencies to secure grant funding, staff specialized projects, and provide technical support and facilitation expertise; and

WHEREAS, proposed Senate Bill 1264 and House Bill 1125 will remove authorization and all references to Regional Planning Councils from the Florida Statutes, depriving the people of the State of the important work the Councils do.

Section 1. The Legislature is urged to remove all references to Regional Planning Councils from Senate Bill 1264 and House Bill 1125 or any similar proposed legislation and to leave Regional Planning Councils in the Florida Statutes; and

Section 2. This resolution shall take effect immediately upon adoption hereof.

Florida Regional Planning Councils: SB 1264 & HB 1125 Fact Sheet

Regional Planning Councils oppose the portions of SB 1264 and HB 1125 that remove all references to Florida's 10 Regional Planning Councils (RPCs) from Florida Statutes. Removing RPCs from Florida Statutes would negatively impact the state agencies, local governments and communities, small and large, who rely on RPCs to provide cost-effective services. Therefore, we respectfully ask that the language concerning RPCs be removed from both bills.

- RPCs save state resources without duplicating services: RPCs provide state agencies with a cost effective and efficient way to provide services and administer programs across Florida, which saves state resources.
- RPCs help local governments meet state requirements and save money: RPCs are recognized in Florida Statutes as the state's only non-regulatory, multipurpose regional entities that are positioned to address complex, regional and statewide challenges with innovative, effective solutions that meet the needs of the communities in each region.
- RPCs provide critical services to small and rural communities: RPCs ensure that small communities and
 rural areas can access technical assistance, grants and programs that would otherwise be out of reach due
 to limited resources and expertise.

<u>Rural Communities and Small Urban Communities:</u> Local Planning Technical Assistance; Map Modernization with GIS; Economic and Land Use Analysis; Economic Development Strategies; Rural Transportation Planning and Transportation Disadvantaged Programs; Emergency Preparedness and Long-Term Recovery Support.

- RPCs assist municipalities and counties by providing technical assistance and data/GIS expertise for policy analysis and guidance concerning issues such as, but not limited to, implementing state initiatives, conservation strategies, economic development, emergency management, transportation, ecotourism and trails, land use decisions, and other needs including day-to-day operations.
- Many fiscally constrained rural counties and small municipal governments have few planning staff and limited resources. RPCs provide professional planning and GIS services to local governments to assist in implementing their comprehensive plans and land development codes and to achieve community visions with data and map modernization. This includes assistance with state growth management and community planning requirements and other state regulations. RPCs provide these critical services, giving these communities the ability to meet state requirements and support development.

Examples of RPC Projects & Services:

- The Central Florida RPC has completed a local mitigation strategy and continuity of operations plan for Hardee County and an economic development strategy for DeSoto County, and numerous additional projects at the request of their member counties and cities. The Treasure Coast RPC has provided on a pro-bono basis planning and zoning services for the City of Pahokee (population 5,666) and facilitated the first new office building and apartments in more than a decade.
- RPCs implement the Transportation Disadvantaged Program which serves citizens that do not have access to transportation by providing bus transportation to medical services, work, school and other essential locations.

<u>Economic Development Programs</u>: U.S. Department of Commerce EDA designated Economic Development Districts; Small Business Revolving Loan Funds; Strategic Planning and Visioning; Economic Modeling; and Brownfield Assessments & Planning

- RPCs are directed in Florida Statute to assist local governments with "activities designed to promote and
 facilitate economic development" in their respective regions. RPCs complement state and local
 government economic development efforts in their role as EDA Economic Development Districts by
 developing and implementing regional Comprehensive Economic Development Strategies; providing grant
 writing and technical assistance to local governments; and providing economic analyses using Regional
 Economic Modeling, Inc. (REMI) software.
- Assist community leaders and local governments in developing and reaching consensus on shared regional goals and strategies with data driven analysis to address regional challenges and maximize opportunities; and implement economic development strategies linking businesses, job creation, infrastructure, land use, and transportation.

• Examples of RPC Projects & Services:

- The South Florida and Apalachee RPCs manage successful Revolving Loan Fund (RLF) Programs to assist small businesses that do not qualify for traditional lending programs. The RLFs serve the local community by enhancing financing opportunities for businesses who want to establish or expand in the region, leading to new jobs and a stronger local economy.
- The East Central Florida RPC launched the first regionwide Brownfield Program in 2021 with a \$500,000 3-year grant from the Environmental Protection Agency. ECFRPC's team identified and conducted Site Assessments on over 100 properties to reduce blight, promote new developments, public health and the environment. Due to the success of this program, ECFRPC has secured an additional \$1.5 million grant to continue the successful program to advance brownfield redevelopment in the region.

<u>Resiliency Planning</u>: Military Installation Readiness; Vulnerability & Adaptation Planning; Flood Mitigation; Florida Wildlife Corridor Planning; and Grant Writing and Administration.

• RPCs conduct state-funded vulnerability assessments, map coastal risk scenarios, and develop strategies with critical stakeholders to determine long term plans to mitigate and adapt to changing conditions.

• Examples of RPC Projects & Services:

- Direct partnership and funding with the Department of Defense to ensure community Military Installation Readiness. This is implemented through the Military Installation Readiness Review (MIRR) process to analyze risks and future climate conditions and implement actions to foster, protect, and enhance military installation mission readiness. Six of Florida's RPCs have conducted MIRRs for their region in partnership with DOD including Emerald Coast RC, Tampa Bay RPC, South Florida RPC, Central Florida RPC, East Central Florida RPC and Northeast Florida RC. RPCs are now working with regional stakeholders, the State of Florida, and the U.S. Department of Defense to secure funding for planning and infrastructure projects that will enhance mission readiness and national security.
- The Apalachee RPC is currently managing the Franklin County Living Shoreline project that will create new nearshore reefs and facilitate natural restoration of marshes along Highway 98 to protect infrastructure, evacuation routes, and reduce shoreline erosion. ARPC was awarded a \$15 million grant and works closely with county and private sector partners, who were not otherwise eligible to apply for this grant.
- Six RPCs across the state are working together through the **Community Development Block Grant-Mitigation program** to study changes in rainfall intensity and inland flooding to identify and mitigate against risks and provide data to support **Resilient Florida** priorities. In addition, cross-jurisdictional projects will be brought forward for communities to implement in conjunction with state and federal resources.

<u>Emergency Preparedness and Long-Term Recovery Programs:</u> First Responder Training; Emergency Response Planning; Healthcare Emergency Preparedness; and Long-Term Recovery Support

- RPCs work closely with first responders and state emergency management staff to ensure that
 communities are prepared for hurricanes and other natural disasters, as well provide first responder
 training for large scale medical emergencies, hazardous materials emergencies, and urban search and
 rescue throughout the state.
- RPCs provide compliance and documentation assistance to private industry on Hazardous Materials storage, ensuring notification to FDEM and emergency responders.

• Examples of RPC Projects & Services:

- The East Central Florida RPC Emergency Management team coordinates training and resources for all of Florida's Urban Search and Rescue Task Forces in partnership with the Florida Department of Emergency Management. All RPCs collaborate to bring hundreds of firefighters and other first responders, experts, instructors, and businesses together each year at the annual Florida HazMat Symposium training event and skills competition, to ensure that local responders have the best information and training available.
- The Tampa Bay RPC developed Project Phoenix 2.0: The Recovery exercise that examines critical issues and capabilities of Tampa Bay area small businesses and emergency management agencies during disaster recovery. This exercise simulates a Category 5 hurricane hitting Tampa Bay and incorporates lessons learned and words of advice from small businesses impacted by Hurricane Michael in 2018. The Project is being updated once again to include new data garnered from Hurricanes Debby, Helene, and Milton.

<u>Transportation Programs</u>: Rural Transportation Planning and Transportation Disadvantaged Programs

• RPCs collaborate with FDOT, the communities they serve, local governments, their transportation agencies, and stakeholders to plan and implement innovative transportation solutions, such as complete streets, greenways and effective transit design.

• Examples of RPC Projects & Services:

- The Emerald Coast Regional Council developed a multi-faceted initiative coined as the 7-Layer Cake. The plan is comprised of seven projects that improve the Northwest Florida region safety and traffic efficiency. The projects address strategies and technologies to reduce traffic accidents, the installation of broadband fiber to support the new technology, and the creation of the Transportation Management Center to coordinate the new systems to reduce traffic accidents and save lives.
- The Treasure Coast and South Florida RPCs worked with the South Florida Regional Transportation Authority (Tri-Rail), municipalities, and developers to facilitate Transit Oriented Development (TOD) across the system, leading to the approval of hundreds of new apartments at the Boca Raton Tri-Rail station and advancement of TOD at other station sites as well. The developer will pay to lease the land from Tri-Rail, reducing the need for operating subsidy, and new affordable housing will boost system ridership while accommodating growth in the area. Building on this success, more sites are in the planning process.

Who pays for the important services and programs provided by Florida's RPCs?

• RPCs are funded by member counties, cities, federal grants, and specific state contracts for services. RPCs do not receive general appropriation dollars and are not staffed by state personnel.







Background: The Central Florida Regional Planning Council received grant funding from the US Department of Commerce, Economic Development Administration, for a Multi-Jurisdictional Transportation Corridor Study to support economic growth and development along SR 60, US 17, and US 27. The study will address existing conditions such as stormwater management, hurricane recovery, and economic drivers to enable industrial growth, job creation, and expansion of economic opportunities within and adjacent to the identified corridors including: SR 60 from Mulberry to Lake Wales; US 17 from Polk/Hardee County line to Winter Haven; and US 27 from Frostproof to Lake Wales.

Staff issued a Request for Proposals for the project received one proposal from the firm listed below:

US EDA Grant: Multijurisdictional Corridor Study - Project Overview

Background:

The US Economic Development Administration is providing a FY 2023 Disaster Supplemental funding opportunity in response to Natural Disasters from 2021 and 2022 including those communities impacted by Hurricane Ian. Staff submitted a grant application 2023 and has now received the grant award. Staff requests authorization for the Executive Director to execute the agreement and administer this grant. The grant will allow for the development of a **multi-jurisdictional corridor study (Study)** to identify opportunities to attract investment through implementation of strategies enabling job creation, an increase in tax revenues and additional growth opportunities. The Study will also assist in the identification of emerging and declining industry clusters or sectors; competitive advantages, and the possibilities for collaborative industry partnerships.

This comprehensive planning effort will support disaster economic recovery activities that address the impacts of Hurricanes Ian, flooding, and other natural disasters helping the region to become more resilient. The grant is to be administered over a 24-month time period. The grant award amount is \$240,000 with a \$60,000 match for a total project cost of \$300,000.

Scope of Work: Multi-Jurisdictional Transportation Corridor Study

Project Description:

Prepare a transportation corridor study to support future economic growth and development. The study will address existing conditions, stormwater management, and economic drivers that could potentially attract private investment and enable industrial growth, job creation, increase tax revenues and expand economic opportunities within and adjacent to the identified corridors which include SR 60 from Mulberry to Lake Wales; US 17 from Polk/Hardee County line to Winter Haven; and US 27 from Frostproof to Lake Wales.

Economic Assessment:

Inventory of major corridors and economic and market analysis. The economic assessment identifies existing and potential industry clusters that could drive economic development within the corridor in the future.

- Demographic and Economic Analysis
- Business Cluster Analysis (Emerging or declining clusters or sectors and projected impact on the corridors' competitive advantages and ability to build capacity for economic development)
- Transportation Corridor and Economic analysis

Transportation Assessment:


segments, major intersections/interchanges, rail sites and freight movements, aviation airports (Winter Haven, Bartow, Lake Wales), traffic volumes, bicycle, pedestrian, and transit conditions. The study will assess the quantity and quality of the study area's existing transportation network and reasonable expectations for expansion.

Land Use Assessment:

Overview of land use characteristics; review of existing plans and studies; review of existing and future land use, zoning; and review of socioeconomic conditions.

Infrastructure Assessment:

Identification of opportunities and challenges for development and redevelopment of the corridors respective of central water, wastewater, stormwater, electric and natural infrastructure and broadband infrastructure. The assessment will reflect the study area's existing stormwater infrastructure, identify existing flood prone areas, and infrastructure that may be at risk should a future flooding event and or disaster arise.
